- Delivering benefits to spouses of veterans (Wisvets.com)
- Largest living veterans group currently are the Vietnam Veterans
- Evers executive order for the blue ribbon commission
- Focusing on WI veterans issues and needs (Native American vets)
- Long term care facilities are struggling with shortages. Industry lost 250,000 employees
- Workforce Development and Education set for June 22, 2022
- Outreach and Recovery happening in all 72 counties

- Veteran run businesses have received \$300,000.00 in grants for non-profit
- Past two years there have been 2,000 applicants and 4,000 veterans assisted
- Union Grove Vets Home has fought with staffing issues, due to covid. This shortage actually began prior to covid. Unfortunately, Union Grove has received the most citations in the state.
- King has had significant losses to our WWII veterans. They are also in need of a new kitchen.
- Chippewa Falls is in need of expansion
- National Guard has been utilized to help with these shortages, and have received training to become CNA's.
- Termination of employees for refusing the covid vaccination has been a large issue across the state.
- Veteran workforce can assist the veterans into the reintegration for civil employment through three steps; 1- Education in prior service, 2- education in service and 3- education after service
- Suicide prevention services are always needed for PTS, TBI and Suicide
- Homelessness can be assisted with tiny homes, but the veterans need more than just a roof over their heads.

President Report – Demske

- DVA (Nationally) has taken no action on Toxic Exposure.
- A plan to sue the secretary for non-action has been set
- The BOD has agreed unanimously
- University is taking on case, without charge
- The is no national registry for birth defects as of yet
- PACT ACT has passed the House. The Senate made some changes and it went back to the House, where they are now claiming it will cost too much money
- Burn Pits have 23 presumptive illnesses attached to it. Eligibility will begin in 2023, and applications will go through 2033. The estimated cost will be \$150,000,000,000,000 (Billion)

Legislative -

- HR3967 Pact Act has added 24 presumptive illnesses
- Arlington is almost full currently, and an expansion is being fought by residents in the area. There is a search for more land.
- Dr. Whittle research post card mailing to all VVA members for a PTS survey is planned. The hope is to get 10% to respond. The need to work with WDVA is real, as the costs may be near \$1,000.00. A motion to provide \$1,000.00 towards this mailing was made by Foye and seconded by Graff. The motion carried without objection.

AVVA -

- Membership has broken the 10,000 member barrier again, and hopefully will continue to grow.
- Missouri was the top state in membership this past month.
